



## 2012 ABSDA Scholarship & Bursary Program

**Committed to continuing education for  
our Members and their families**

### Eligibility:

- 1) Dependent of an employee, manager, owner of a building supply outlet (ABSDA Dealer Member); or supplier (ABSDA Associate Member), and active in the industry at the time of application. This person must have been employed with the ABSDA Member Firm a minimum of one year.
- 2) All full and part-time employees as listed in item 1.
- 3) Either graduated high school or in final year of high school.
- 4) High school graduation equivalency.
- 5) Accepted at a recognized Canadian University or Community College for **first year studies**.

### Definitions:

- **Scholarship:** Non-renewable sum of money presented to an eligible student to help in their first year of studies. The Scholarship award is based primarily on academic merit as opposed to financial need.
- **Bursary:** Non-renewable sum of money presented to an eligible student to help in their first year of studies. **The student must state financial need and exhibit a satisfactory academic record.** The Bursary would be based primarily on financial need as opposed to academic merit.

### General:

- 1) ABSDA Member Firms may photocopy, post and distribute applications forms as necessary.
- 2) Students must include all required material as listed on the application form or provide by no later than **April 30, 2012**.
- 3) ABSDA reserves the right to verify all information.
- 4) Information regarding this program may be obtained by calling the ABSDA office at (506) 858-0700.
- 5) The Scholarship and Bursary Committees consider academic standing, financial need, school and community involvement.

ABSDA reserves the right to withhold the scholarship and bursary awards if no acceptable applications are received. The Bursary and Scholarship Programs may be altered, amended or discontinued at the discretion of the ABSDA Board of Directors. *The decision of the ABSDA Scholarship and Bursary Committee and ABSDA is final and not open to appeal or review.*

- 6) Winners will be notified early June of that year.
- 7) Cheques for scholarship and bursary recipients will be presented at high school graduations if possible.

*Please note: Applicants may apply for both the ABSDA Scholarship Award and the ABSDA Bursary Award, but would be limited to one scholarship or bursary award, not both.*
